Important Customer Information

1. All containers have weight limits agreed upon before delivery. Any container that is heavier than the agreed upon tonnage limit will be billed at the rate listed to the left. That charge is known as an overweight charge.
2. There is a **\$175.00** charge for all unsuccessful attempts to deliver or pick up containers or customer requested relocations.
3. If this is a C.O.D. account, you must pay for each pick up and any past due charges owed in advance of each delivery.
4. Credit Cards are required for C.O.D. customers to place orders. We may accept payment by check and hold the credit card as backup against returned checks or unpaid balances more than 30 days old. **By signing this waiver, you grant to City Carting the authority to charge your credit card for all applicable fees and taxes and notify you by mail of those charges.**
5. We will not allow our drivers to sit on-site while containers are being loaded without prior approval. Any wait time will be charged an hourly rate to be agreed upon before delivery of the container.
6. Containers are to be filled level with the top, with **NO** debris sticking out of the top or sides of the container.
7. We are not responsible for damage to placement surfaces. The customer is to provide adequate planking or suitable supports between the container and placement surface.
8. We are not responsible for issuing permits. It is the sole responsibility of the customer.
9. Containers are not to be moved by customers. Any damage caused to our containers could result in damage claims or repair charges.
10. City Carting reserves the right to remove containers on the 30th day unless the customer has requested differently through customer service.
11. **Unacceptable Items:** The following items cannot be loaded into your container:
 - NO** 55 gallon drums empty or full
 - NO** car batteries
 - NO** asbestos or asbestos containing products
 - NO** Hazardous Materials (liquids such as paint, oil, solvent, pesticides, etc.)
 - NO** CFC containing appliances (such as air conditioners, refrigerators, freezers, de-humidifiers, etc.)
